If your project involves licensed beds, the application must identify the number of beds to be converted, added, or delicensed.

The application filing fee is \$10,000.00 plus 0.015 times the total project cost up to a maximum fee of \$50,000.00. The minimum fee for projects with no capital expenditure is \$10,000.00. The nonrefundable filing fee should be submitted with the application on or before the application due date listed above.
